TECHNICAL SPECIFICATION OF AIRCRAFT FLUSH CART QTY-06 UNITS.

SCOPE: The self-propelled Aircraft Flush Cart shall be capable of providing adequate ground service to aircraft lavatory connections, transporting, disposing the lavatory waste removed from the aircraft and allowing for quick flushing and cleaning of the waste tank and be pre charged in short time to narrow body as well as to the wide body airplane: Bombardier Dash 8/ Q 400, A318/319/320, B 727, B737, B757, B767, B777 of all series, B 787, A330, A340, MD-11, and up to B747-400/800.

MAIN FEATURES:

- A. Equipment have to be self-propelled & the overall dimensions shall be kept to a minimum. Areas of the vehicle intended to operate under any part of the aircraft should leave a minimum of 0.5 m (19.68 in) clearance.
- B. Must have water tank capacity 300 US gallons (minimum). * (1 US gallon = 3.7854 liter).
- C. The capacity of the water pumps shall be as follows: Minimum 4 gallon per minute at 50 psi pressure measured at the end of water delivery hose.

- K. Must have water & waste tanks made of good quality stainless steel.
- L. The tank shall be mounted on the chassis by means of a floating type suspension to absorb the dynamic impacts and the vibrations during operation.
- M. The bottom of the tank shall be sloped towards the lowest point and there shall be a valve of at least 50 mm (2 in) diameter to drain the tank by gravity.
- N. Must have power steering.
- O. Must have operator cabin with Air cooling system.
- P. All the cables, related with wiring should be fire resistance.
- Q. The unit shall be capable of turning with a swept radius of less than 40 feet.
- R. i) The hose/pipe fitted with the Flush Cart to collect the waste from the aircraft lavatory must be designed in such a way that the waste is passed away from the aircraft to the waste tank smoothly without any manual help.
ii) A vacuum pump must be installed in a suitable location to suck waste from the aircraft lavatory and pass it way to the tank of Flush Cart through the hose/pipe.
- S. Must have a robust structure to carry the rated load with maximum stability.
- T. Must have strict compliance and meet all the safety specifications & requirements as laid down in the IATA Aircraft Handling Manual (AHM) AHM 974 in conjunction with AHM 904, AHM 905, AHM 910, AHM 913, AHM 915, AHM 1001, ISO 1034/MS33562D.
